YMCA GIVES HOPE TO YOUTH

Enriching the lives of hundreds of youth is something we do every day. In response to the epidemic of youth violence in our area, we took our work to the next level. This new initiative, called **Hope for Youth**, involves working with at-risk youth; atrisk for not completing high school; at-risk for becoming involved in gangs, violence or criminal activity; or at-risk for not developing to their fullest potential.

By hiring additional staff, collaborating with other organizations, recruiting volunteers and standing alongside youth in these situations, we help them learn job skills, set goals, get an education and have a positive outlook toward their future.

Community deterioration and juvenile delinquency are pressing social issues that the YMCA works to address.

We lead the way in responding to the needs of area youth by offering educational and character development programs such as:

- Early learning (for children ages 6 months to 6 years)
- Half-day preschool
- Before- and after-school care
- Daytime summer camp and overnight summer camp
- Teen Leaders Club and youth leadership programs
- · Counselors and Leaders in Training
- International Service Trips
- Educational programs aimed at reducing summer learning loss
- Integrative Arts Program which provides arts and humanities opportunities to low income students

- The Skyline YMCA and commuter bike hub were opened on South Harrison Street in Downtown Fort Wayne. Those working and/or living downtown now have a convenient before-, duringor after-work venue to reduce stress with a workout, learn new strength and conditioning techniques with a personal trainer, or participate in volunteer efforts to give back to the local community.

EVERYONE HAS A PLACE AT THE Y

Social responsibility comes in many forms. From making the Y accessible to people with disabilities, to providing financial assistance to people without the means to afford a Y membership, our mission ends with "...for all." This means we are intentional about making sure that everyone knows there is a place for them at the Y.

As part of our efforts to build a culture of inclusion, we focus on making the Y more accessible to the population of approximately 20,000 individuals with intellectual or physical disabilities who reside in our service area. As we designed the new Jackson R. Lehman Family YMCA, we included a sensory room and ramp access to a second pool, which will also provide warm water therapy, adaptive equipment and adaptive programs.

SAFE KIDS THRIVE WITH HELP FROM THE Y

The Y started a local Safe Place program in response to the increasing rate of child abuse and neglect in Allen County. This national program provides youth in crisis situations access to immediate help and supportive resources. Sites were initially established at six YMCAs and then all 18 Fort Wayne fire stations became Safe Place sites.

If a young person needs help, they can go to any location that displays the distinctive yellow and black Safe Place sign. The program is a natural extension of the free crisis intervention services that YSB has been providing for more than 20 years. Safe Place keeps youth safe, helps families through crises and saves lives.

2016 HIGHLIGHTS

In the summer of 2016, **Y** on the Fly (our free mobile summer program) provided more than 700 children with fun, safe and structured physical activities and healthy snacks—and offered opportunities to role model and support children ages 2-16 in 10 underserved neighborhoods in the Fort Wayne area. In order to make the Y available to everyone, **we provided 24,802 people with financial assistance** in the form of reduced membership rates or program fees, ensuring that programs and services are available to all. We awarded more than \$1.9 million in financial assistance in 2016 throughout Allen, Whitley and Adams Counties. This means one out of every five people participating at the Y receives financial assistance in order to participate.

As part of our 7th grade initiative, **454 7th graders received free YMCA memberships**, which offered positive after-school activities, homework help and education about volunteerism and giving back.

With a goal to help a family identify its strengths, set goals and work toward keeping youth in school and on track to graduate, our **Youth Service Bureau's free services provides the opportunity for a more promising future** to local youth at-risk for not completing school. Of the **1,280 students and families who participated in the program in the 2015–2016 school year, an incredible 91% got back on track academically and avoided the juvenile justice system.**

554 children experienced the thrill of nature, built character and made friendships at YMCA Camp Potawotami's summer resident camp. 5,513 children and teens built self-confidence and learned how to work as a team by participating in youth sports programs. 749 men, women and children learned how to save a life through the YMCA's CPR, first aid, lifeguarding and other life-saving courses. **5,455 youth reduced their risk for water-related accidents** by participating in the YMCA's swimming lessons.

2,530 children participated in our before- and after-school care programs, and were encouraged to reach their fullest potential in a welcoming, supportive environment.

Through the YMCA's Celebration of Youth Program in conjunction with Wells Fargo, six young adults were recognized for demonstrating the Y's core values of caring, honesty, respect and responsibility with a one-year Y membership and a \$1,000 scholarship to pursue post secondary education.

132 men and women reduced their chances of developing diabetes by participating in the YMCA's Diabetes Prevention Program. 1,880,600 visits were made throughout Allen, Whitley and Wells County YMCAs, where people found community, connection and purpose. **61 people benefitted from the LIVESTRONG® at the YMCA program**, which provides support, encouragement and confidence at re-engaging in life after cancer.
